#### Agenda item 6. General Discussions

Chair Rumbo lead open discussions.

- Current unemployment rates and disparities between the lowa overall unemployment rate vs. minority unemployment rate.
- What are the key components contributing to those disparities and how can this help?

Ryan Murphy, Labor Market Information Director, IWD, presented unemployment data. Definition of "unemployed" was discussed. Unemployed = available or looking for work.

Jessica Dunker shared her involvement in the Child Labor Laws Working Group. Group is working on a rewrite of the child labor law, addressing some of the current issues businesses

are experiencing.

- Create equity between working teens and extra-curricular activities.
- Working hours of 7 pm to 9 pm during school nights.
- Allowing work license similar to school license to address transportation issues for 15-year children.
- Looking at simplification for employers.
- Remove dangerous activities out for teens.
- IWD attorney is working on rewrite and hopeful that Director Townsend can propose an agency bill to the legislative.
- Work is advancing pretty quickly with multi-working parts.
