## Adult Education Report—May 2016

## **Enrollment Update**

As of May 16<sup>th</sup>, we are at 99% of our FY16 enrollment goal. Enrollment as defined by the Department of Education is those students attending 12 or more hours in classroom activities. We continue to also show increased progress on the number of students post-tested and those showing level gains on their CASAS post-assessments. As we end our last 8 week session for the program year, staff will be working on ensuring we capture additional post-tests for eligible students.

## **Commencement Ceremony**

On Friday, May 13<sup>th</sup>, the Adult Education program celebrated its annual commencement ceremony, recognizing 237 students that have graduated in the last 12 months with an Iowa High School Equivalency Diploma (HiSET completion,) a Kirkwood Adult High School Diploma, or a local school district diploma. Approximately 45 students participated in the ceremony, with speeches given by program graduates, as well as Dr. Mick Starcevich, Kirkwood Community College President.

## **IowaWorks Programming for FY17**

We are currently exploring changing our programming at the lowaWorks office for FY17 to offer structured courses in addition to open lab opportunities for ABE/HSED students. We currently have open lab time 3 days per week for all students. Best practice in adult education is to move to managed enrollment, which is having defined courses with set start dates and end dates. Students in managed enrollment show better overall outcomes than those who only attend on a drop-in basis.

Current ideas under discussion would have classes for students at the 6<sup>th</sup> to 8<sup>th</sup> grade levels at lowaWorks, with lab time for those at the 9<sup>th</sup> grade or above. Students scoring below a 6<sup>th</sup> grade level would be referred to classes or programming at the Kirkwood Center for Lifelong Learning. We are also looking at having scheduled office hours for a high school pathway navigator at lowaWorks. Additional updates will be shared as plans progress.
