- Financial Report Renee Erbes Renee went over the financial report. There's lots of grant money right now. Next year there won't be as many grants.
- Sector Board Reports Shalimar Mazetis, Starlyn Isaacson and Terry Bailey Shalimar informed us that Starlyn will take over the healthcare and Shalimar and Terry will take over IT. With IT they focus Junior High and what type of careers are available in IT.

Ben Humphrey go back to me letting me know that the member must meet the applicable WIOA membership criteria for a business representative and that the CEO Board will nominate the member to the Governor.
- Work Experience Wage Rate Renee Erbes The current rate is \$8 and length of employment is 6 months. A company should know if

someone is going to work out after 2 months. Renee would like Board's guidance should the amount be more perhaps cap at \$11 and duration 2 months? This is an action item so will table for now.

13. Director's Report – Renee Erbes

Renee went over the handouts for unemployment rate. 599 new members used the center in March and there were 1,579 returning members. VODEC had a successful revers job fair.

Randall McQueeney mention the state goals is to reduce minority unemployment. They are currently compiling data. More information to come.
