VACANCIES

Brown reported that currently there are three vacancies, a labor, business, and school ex-officio vacancy.

TITLE 1 WIOA UPDATE

Howard reported that the A-Game training was completed in October. The A-Game is one of the classes taught in the school systems, along with NCRC and Colors trainings.

She also reported that they are currently under spent in Adult but have hired a part-time staff person to assist in bringing their numbers up. This person is serving as the liaison between the Burlington Correctional Facility and Adult programs. The Youth program is where it should be and DW is slightly under budget.

TITLE II AEL UPDATE

Mulch reported that they have hired another part-time instructor.

She also stated that graduation was last week at the Mt. Pleasant Correctional Facility and that 11 individuals were eligible to participate in the ceremony, however, only ten individuals did participate.

TITLE III IWD UPDATE

Farley reported that all counties unemployment rates decreased except Des Moines for the previous period, and that the state rate remained flat.

She shared two graphs regarding Lee County Travel Numbers and 2019 Burlington VOS Numbers with the board.

She stated that currently there are 670 jobs listed on IowaWORKS site. They held a job fair at the Mt. Pleasant Correctional Facility where over 150 individuals voluntarily participated, along with ten businesses. Also, they have started a pilot program with the Iowa State Penitentiary to provide classes.

Lastly, she announced that they served more than 100 veterans and their families at the annual veteran luncheon.

TITLE IV VR/IDB UPDATE

Howard discussed a flyer for the Deaf Community event that was distributed to board members.

Miller had no update.

CEO TRAINING UPDATE

CEO See gave a brief overview of his experience with the training that took place on November 20th, and stated that they are waiting on direction for the next steps.
