• Healthcare Sector Board Update: The group has discussed on various occasions apprenticeships for CNA positions. There is great interest in businesses participating in this form of training. Speed Interviewing opportunities have been brought to the group, which has also shown great interest. One facility has started baking cookies and taking them to state boards to thank incoming CNA's for choosing the nursing field. Other facilities are also considering doing this. A variety of classes are now being offered at the Cedar Falls Center including; soft skills, customer service, Basic Life Support and First Aide. Meetings are now being held at area businesses, which seems to be appealing to those involved with the group.

• Cedar Valley Advanced Manufacturing Partnership Update: Janna has been busy meeting 1-1 with businesses involved in the partnership to receive feedback of pros and cons to being involved in the group and to start identifying some initiatives that can be worked on moving forward. Upon completion of this, she will then begin doing outreach to new businesses. The group was involved with area parent-teacher conferences in order to advertise manufacturing careers and to provide accurate information to parents about manufacturing. This is the second year that the group has participated in the conferences. The group has now started planning the Manufacturing Conference that will be held on March 20, 2019.

Title II Adult Education and Literacy

HCC through WIOA Title II Adult Education and Literacy provides education for those who need to earn a HS equivalency diploma and/or gain proficiency in the English language.

I-BEST/IET/IELCE

• Pilot I-BEST (Integrated Basic Education and Skills Training) class connected to Business and IT industry sectors began August 2018. Class is called Business Computer Applications I-BEST. Included

in the course components: three-credit hour college class Databases and Spreadsheets, basic skills instruction in English language proficiency, math, reading, writing, and transferable and soft skills for the workplace. Students who successfully complete will earn three college credits and will have begun a career pathway for Business or IT; they will also be positioned to enter a multitude of other career pathways as computer skills are necessary for most jobs and lack of these skills has been identified as a barrier to employment in Region 7.

- WIOA includes mandate for IET (Integrated Education and Training). I-BEST is a nationally recognized model for providing IET.
- IELCE (Integrated English Literacy and Civics Education) programming was piloted 2017-18 and is continuing in the 2018-19 school year. This new IET option at Hawkeye offers ELL students with appropriate English ability the opportunity to learn digital literacy skills in an integrated manner. Students learn Word, Excel, PowerPoint, Google applications, and workplace transferable skills while also increasing their English language proficiency. We have had increased partnership with IowaWorks this fall: Coretha Montouth co-teaches the class once a week, providing instruction in resume writing and interview skills. Coretha will teach the class one day a week on her own next semester; the curriculum will be IowaWorks' Customer Service Certificate. IowaWorks staff is also arranging for practice interviews to be held at IowaWorks later this fall for the IELCE students, providing real-world interview experience for the students.

ENGLISH LANGUAGE LEARNING (ELL) classes
