 - i. Michael:
 - 1. They've been submitted and waiting for the Iowa WDB to do; has made the following recommendations to them:
 - a. Move bathroom to the women's by the back entrance
 - b. Purchase a real doorbell vs. a battery-operated one that won't freeze and work in adverse weather conditions
 - 2. Some of the signs need to be moved and repaired through Ticket to Work funds, along with the doorbell
 - ii. Jesse: there should be a link to a Google drive folder with everything flipped in the PDF that was sent by Michael
 - iii. Michelle: does that women's bathroom have the drain in the middle because that drain might be a possible trip hazard; the previous floor was totally level
 - 1. Michael: a walker would have to access
 - 2. Michelle: they were grandfathered in
 - iv. Michael: should we go ahead with a motion to move the bathroom or keep it where it is until the Iowa WDB gets back?
 - 1. Jesse: that doorbell really needs to be fixed

Funds may be utilized at the discretion of the Iocal workforce development board. Fund requests must be submitted to the SWIWDB Executive Director. These requests will be approved by the Disability Access Committee and Executive Committee before expenditures are completed.
