Board Insurance Discussion

- Jon Bell reviewed information and determined that everything could be covered except fraudulent activities.

Updates - COVID-19

- Jon Bell Cedar County: Open since mid-June with shields. Permanent glass installed around the end of June. Scheduled appointments only but if an opening, they will take walk-ins. Drop boxes also available option.
- Bob Yoder Washington County: Courthouse open on Tuesdays in the afternoon. Only allow up to 3 in each department at a time.
- Pat Heiden Johnson County: Appointment only since 6/8/2020. Concerns with students returning to campus next month with a possible surge in positive cases. Masks required in Johnson County.
 Collaborative effort with Department of Health. More authority to mandate. Iowa City Mayor also mandated masks in public. Working with all cities in Johnson county on consistent efforts/requirements.
- Bruce Adams Iowa County: First COVID-19 death in the county. Courthouse requesting appointments but will try to assist with any walk-ins.
