Answer: Each center is equipped with computers and or laptops, personal scanners for identified programs like Title I, and multiple center use copier/scanners for staff. Depending on staffing levels of providers, extra computers/laptops and individual scanners can be ordered through the IT procurement process. Each center is also equipped with computer labs, conference rooms for workshops and classes, as well as a "Welcoming" and "Career Exploratory" area with computers for job seekers that are utilized for initial intake, self-services or participant level career services.

5. What are the shared costs in each Center, including rent?

**Answer:** Rent is calculated by the allocated space of each partner or provider based on total square footage of staff and common space and will generally include the shared cost of items like heating, air, electric or even janitorial. Other shared costs outside of rent are based on FTE (Full-time equivalent) staffing and might include items like general office supplies, cleaning supplies, share of copier usage, postage, network or phone usage and common purchases for equipment or items that benefit all partners and providers in the centers.
